All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, Section 1, Township 1, Range 1, in a tract entitled "Section 1, Lot 1, Block 1, Greenville, S.C.", as shown on the map of the City of Greenville, County of Greenville, State of South Carolina, prepared by C. O. Hause, Esq., Surveyor of Greenville, according to said plan, in full consideration of the sum of Three Dollars (\$3).

BEGINNING at a point on the north line of said tract, where said tract meets the public road, S. 45-16 E., running from the south line of said tract eastwardly, and running along the south line of said lots, S. 63-36 W., S. 45-16 E., S. 63-36 W., N. 45-16 W., N. 45-16 E., P.T., from an iron pin, running with the south line of lots 1 and 2, N. 45-16 E., P.T., from an iron pin on the south side of the public road, before the point of beginning.
