WHEREAS, I, Dorothy Octavus Woodson

(hereinafter referred to as Mortgagor) is well and truly indebted unto Jo Ann L. Ables

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Four Thousand Three Hundred and no/100----- Dollars (\$ 4,300.00) due and payable \$82.00 per month on the 1st day of September 1975, and a like payment on the first of each month with no interest until maturity, which shall be on August 1st, 1980.

with interest thereon from date at the rate of _____ per centum per annum, to be paid: beginning at maturity on any balance monthly.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, State of South Carolina, Saluda Township, and having the following notes and bounds, to-wit:

BEGINNING at an iron pin at the joint corner of land owned by Mrs. Griffith on the West side of Trammell Road, thence N. 77 - 1/2 W. 330 feet to the branch which is the line; thence up the meanderings of the branch, 165 feet to the iron pin at the joint corner of land owned by Marie Fritchett Johnson; thence S. 57 - 00 E. 285 feet to iron pin on the West Side of Trammell Road, continuing with said road, S. 4-30 W. 207 feet to iron pin, the beginning corner.

This being the same property being owned and held by Mortgagee and being recorded along with deed, including all improvements thereon.



Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrance except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
