WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and impaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes insurance premiums, repairs, or for any other purpose,

NOW KNOW ALL MEN. That the Mortgagor, in consideration of sold debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor's for the Mortgagor's and and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is bereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate.

All that certain piece, parcel, or lot of lood with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville being shown as Lot 18 of Albans Acres a plat of which is recorded in Plat Book 4-N at Page 31 and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the westerly side of Fairground Road at the joint front corner of Las No. 17 and 18 and running thence with the line of said lots, S69-41W 435. 4 feet; thence S19-09 E. 125 feet; thence N69-41 E. 439. 4 feet to a point on Fairgrounds Road; thence with Fairgrounds Road N20-59 W. 125 feet to the point of beginning.

This being the same conveyed to us by W. R. Julian, as Trustee, by deed dated July $30,\ 1975,\ \text{and}\ \text{recently}\ \text{recorded}.$

This mortgage secures a note in the original sum of \$19,550.00, executed by the mortgagors to the mortgagee on July 27, 1973. That note was originally secured by a mortgage recorded in the RMC Office for Greenville County in Mortgage Book 1287, at Page 1, which covered Lot 17 of Albans Acres subdivision, but it was subsequently discovered that the dwelling house supposedly located on Lot 17 was actually constructed on Lot 18. The purpose of this mortgage is therefore to correct the error and the mortgage covering. Lot 17 is being cancelled.
