MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

John H. and Betty S. Corbitt

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Ten Thousand One-Hundred and No/100------(\$10,100.00)

Dollars as evidenced by Mortgagor's promissory note of even date herewith which note does not contain, a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of One Hundred Two

And 45/100------(\$ 102.45) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable

15 years after date; and

WHEBEAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and impaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may be reafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes insurance premiums, repairs, or for any other purpose:

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (53,00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is bereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain pace, parcel, or lot of land with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville known and designated as Lot no. 16 of Hampton Annex as shown on plat recorded in RMC Office for Greenville County in Plat Book "F" at page 59, said Lot fronting 50 feet on Darwin Street, and being one of the lots of land conveyed to J.L. Pace by E. Inman, Master by deed dated November 27, 1937 and recorded in Deed Book, Vol. 195 at page 74.

This property was conveyed to W.H. Bishop by Deed of J.L. Pace, dated January 27, 1939, and recorded in Deed Book 208, page 260 in the Greenville County R.M.C. Office. W.H. Bishop subsequently conveyed an undivided one-half (1/2) interest in this property by Deed, Dated November 15, 1956, and recorded in Deed Book 565, page 257 in said R.M.C. Office to his wife, Lillian E. Bishop.

This is the same property conveyed to the mortgagors herein by W.H. and Lillian E. Bishop by deed recorded in the R.M.C. Office for Greenville County on August 4, 1975 in Deed Volume , at page .
