WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Eighty Thousand and No/100-----DOLLARS

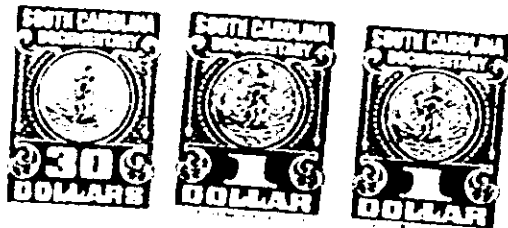
(\$ 80,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville at the Southwestern intersection of Chapman Road and Thornwood Lane and being shown and designated as Lot #193 on plat entitled "Final Plat of Chanticleer, Section VI" prepared by Webb Surveying and Mapping Company, December, 1972. Said plat being recorded in the RMC Office for Greenville County in Plat Book 4X at Page 59 and having according to said plat the following metes and bounds to wit:

BEGINNING at an iron pin on the Western side of Thornwood Lane at the joint corner of Lots #193 and #194 as shown on aforementioned plat and running thence along and with the Western side of Thornwood Lane N. 21-08 E. 120.1 feet to an iron pin at the Southwestern intersection of Thornwood Lane and Chapman Road; thence N. 23-08 W. 35.7 feet to an iron pin on the Southern side of Chapman Road; thence running along and with said road N. 67-24 W. 130 feet to an iron pin; thence S. 29-06 W. feet to an iron pin at the joint rear corner of Lots #193 and #194; thence running along and with the joint property line of said two lots S. 80-36 E. 185 feet, to the beginning point.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
