THIS MORTGAGE is made by the between the Mortgagor as:

Cornelia M. Carnell herein "Borrower" and the
Mortgagee First Piedmont Bank and Trust Company
Greenville, South Carolina herein "Lender"

WHEREAS, the Borrower is indebted to the Lender in the sum of Forty One Hundred Forty Nine & 36/100 Dollars \$4,149.36, as evidenced by the Borrower's promissory Note of even date herewith, herein "Note", the terms of which are incorporated herein by reference, with principal and interest to be paid as therein stated, the unpaid balance of which, if not sooner paid, shall be due and payable in 36 equal payments of \$115.26 each and beginning September 18, 1975.

WHEREAS, the Borrower may have borrowed other monies from the Lender, which term as used throughout this Mortgage Agreement shall include any Holder, which monies have not been fully repaid and the Borrower may hereafter become indebted to the Lender for such further sums as may be advanced to or for the Borrower's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the Borrower desires and intends to secure any and all of said existing indebtedness and future advances and indebtedness by granting to Lender a Mortgage on the real property hereinafter described, which Mortgage shall be security for all obligations of the Borrower to Lender in the total principal amount of Dollars \$.

NOW, THEREFORE, KNOW ALL MEN that the Borrower, jointly and severally if more than one), in consideration of the foregoing and also in consideration of the further sum of Three and No 00 \$300 Dollars to the Borrower in hand well and truly paid by the Lender at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, TO SECURE TO LENDER the repayment of: (a) the indebtedness evidenced by the aforesaid Note, with interest thereon, to all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage and the performance of the covenants and agreements of Borrower herein contained; and (b) all other money, heretofore or hereafter advanced by the Lender to or for the account of the Borrower and all other present or future direct or contingent liabilities and indebtedness of the Borrower to the Lender of any nature whatsoever to the fullest extent allowed by law, and any modifications, extensions, rearrangements or renewals of any of (a) and (b) all hereinafter collectively called the "Obligations", with the limitation that the total principal amount of said Obligations secured hereby shall not exceed the amount specified in the preceding paragraph, together with reasonable attorney's fees, court costs and expenses of whatever kind incident to the collection of any of said Obligations and the enforcement of the Mortgage interest created hereby, does hereby mortgage, grant, bargain, sell and release unto the Lender, its successors and assigns, the following described real estate:

All that piece, parcel or lot of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 19 as shown on a plat entitled SECTION ONE, JFNEKINS ESTATES, DATESKIET, dated February, 1971, prepared by C. C. Riddle, which plat is of record in the Office of Greenville County, S. C., in Plat Book 4M, page 107, and having, according to said plat, the following metes and bounds, to-wit: Beginning at an iron pin on the northern side of Loraine Drive at the joint front corner of lots 19 and 21 and running thence with the line of Lot 21, N. 26-24 W. 255 feet to an iron pin; thence N. 63-36 E. 150 feet to an iron pin; thence along rear line of lots 4 and 5, S. 26-24 E. 255 feet to an iron pin on the northern side of Loraine Drive and thence with side of Loraine Drive, S. 63-36 W. 150 feet to the point of beginning.

All that piece, parcel or lot of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 5 as shown on a plat entitled SECTION I, JFNEKINS ESTATES, S.W., prepared by C. C. Riddle, dated February, 1972, and having according to said plat, the following metes and bounds, to-wit: Beginning at an iron pin on the western side of Fork Shoals Road at the joint front corner of lots 4 and 5, and running thence with the common line of said lots, S. 63-36 W. 263.8 feet to an iron pin; thence S. 26-24 E. 255 feet to an iron pin on the northern side of Loraine Drive; running thence up the northern side of said Loraine Drive, N. 63-36 E. 241.6 feet to an iron pin at the intersection of Loraine Drive and Fork Shoals Road; running thence through the circle of said intersection, the chord of which is N. 18-07 E. 39.1 feet to an iron pin on Fork Shoals Road; running thence down Fork Shoals Road, N. 27-21 W. 241.6 feet to the point of beginning.
