WHEREAS, I, the said Dorothy C. Dill

in and by my certain promissory note in writing of even date with these presents, am well and truly indebted unto the Citizens Building and Loan Association, Greenville, S. C., in the full and just sum of

Six Thousand and no/100 - - - - - \$ 6,000.00 Dollars,

with interest from the date hereof at the rate of nine per cent. or 9% per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

Sixty and 86/100 - - - - - \$ 60.86 Dollars
 due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection therewith, has been paid, and to satisfy payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and attorney's fees, if any, incurred, and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the laws of said Association, or with any of the stipulations of the note, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection to be added to the amount due on said note and collectible as a part thereof, if the same be placed with an attorney for collection or a creditor or to pay thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS That I, the said Dorothy C. Dill

do hereby mortgage to the Citizens Building and Loan Association, Greenville, S. C., all my interest in the above described real estate, and for the sum of the sum of Three (\$3.00) Dollars to the said Association, and that I, the said Dorothy C. Dill, do hereby pay to the said Association, at and before the sealing and delivery of these presents, except what is hereinabove agreed, have executed, bargained, sold and released, and by these presents do grant, release, and convey to the said Citizens Building and Loan Association, Greenville, S. C., as successively described.

That certain lot, panel or tract of land with improvements thereon, or hereafter constructed thereon, situated, lying and being in the State of South Carolina, Greenville, Chick Springs Township, located north from Greenville, S. C., on the Southern side of Wilson Drive and before shown on plot of property made for T. E. and Dorothy C. Dill by Terry T. Dill, surveyor, dated 3/24/1975, which is the northeast corner of the property shown on plot made for Thelma C. Coleman, recorded in plot book #0, page 240, and has the following courses and distances, to wit:

BEGINNING at pin in Miller Road and running thence with said road, S. 70-36 E., 30 feet to another point in road; thence leaving road and running thence S. 48-55 W., 303 feet to new corner on Coleman line; thence a new line with Coleman, N. 50-25 W., 55 feet to new corner; thence still with Thelma C. Coleman, N. 16-38 E., 166 feet to center of Wilson Drive; thence with Wilson Drive, S. 74-34 E., 102 feet, N. 77-52 E., 40 feet and N. 59-17 E., 66 feet with said drive to the beginning corner and containing 0.51 of acre, more or less.
