WHEREAS, I, the said Roy Durrab
in and by my certain promissory note in writing of even date with these Presents, am well
and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greenville, S. C., in the full and just sum of
Five Thousand Five Hundred and 94/100 ----- (\$ 5,500.00) Dollars
with interest from the date hereof at the rate of eight 3/4 per cent (8.375%) per annum, unpaid interest to
bear interest at the same rate, to be repaid in installments of Ninety Eight and 47/100 -----
----- (\$ 98.47) Dollars
due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest
and all costs, insurance, and expenses incurred in connection with said loan, has been paid, and no monthly payments

in consideration of the said debt and sums of money
aforesaid, and for the better securing the payment thereof, do to the said CITIZENS BUILDING AND LOAN ASSOCIATION,
Greenville, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00)
Dollars to me, the said mortgagor, to hold well and truly paid by the said mortgagee, at and
before the sealing and delivery of these Presents, receipt of which is hereby acknowledged, have granted, bargained,
sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND
LOAN ASSOCIATION, Greenville, S. C., its successors and assigns,

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter
constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick
Spring Township, located in the City of Greenville, on the Western side of Madison Ave.
(Formerly known as Campbell St.), being a plan of property made for Roy
Durrab by John A. Stevens, surveyor, dated July 1, 1970, which plan to be recorded
and has the following notes and borders, to wit: (See book 555 page 216.)

Begins at an iron pin on the Western side of Madison Ave., at rear corner of
lot No. 2 of O. P. Smith pl., plat book 55 page 107, 200 feet from Palmer St., and
runs thence N. 69-00 W., 120 feet along the rear lines of lots 2 and 3 to an iron pin
at corner of lot No. 1 on said plat; thence S. 21-08 W., 143.5 feet to old iron pin;
thence S. 71-45 E., 125.7 feet to iron pin on the West side of Madison Ave.; thence N.
18-51 E., 137.6 feet to the beginning point.
