7. The convenants herein contained shall bind, and the benefits and advantages shall inuse to, the respective heirs, executors, administrators, successors, and assigns of the parties hereto. Whenever used, the singular number shall include the plural and the singular, the use of any gender shall be applicable to all genders and the term "Mortgagee" shall include any payer of the indebtedness herebs secured or any transferor thereof whether by operation of law or otherwise.
