SEND GREETING

WHEREAS, I, the said George L. Paris,

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of

Fifteen Thousand and no/100 - - - - - (\$15,000.00) Dollars.

with interest from the date hereof at the rate of eight and one-half percent (8 1/2) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of One Hundred Forty Seven and 72/100

- - - - - (\$147.72) Dollars
