WHEREAS, we, M. Steven Sandlin and Shelia S. Sandlin

(hereinafter referred to as Mortgagor) is well and truly indebted unto Eunice L. Stokes

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Nine Hundred and NO/100**

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about six miles north of Greer, containing 1 acre more or less, and fronting on S.C. Highway No. S-23-464, and having the following courses and distances according to survey, to-wit:

BEGINNING at an iron pin, corner of said S.C. Highway and other lands of Stokes Estate, and running thence with S.C. Highway No. S-23-464, N. 52 E. 200 feet to an iron pin and corner of other Stokes Estate property; thence along line of Stokes property, S. 35 E. 220 feet to iron pin, corner of Stokes property; thence as rear line along Stokes property, S. 52 W. 200 feet to iron pin; thence along line of Stokes property, N. 35 W. 220 feet to iron pin, the beginning corner, containing one acre, more or less.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
