MORTGAGE

THIS MORTGAGE is made this 17th day of September , 19 75 , between the Mortgagor, Susie Ann O'Dell & Dorothy O'Dell

(herein "Borrower"), and the Mortgagee, Family Federal Savings & Loan Association, a corporation organized and existing under the laws of The United State of America, whose address is \$3 Edwards Bldg., 600 N. Main St., Greer, S.C. 29651 (herein "Lender").

ALL that piece, parcel or lot of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 5 as shown on a plat of Whipporwill Hills, Section 1, prepared by R. B. Bruce, recorded in the RMC Office for Greenville County, S.C. in Plat Book 4N at page 20 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on Bayne Road at the joint front corner of Lots No. 4 and 5 and running thence S. 6-41 E., 219.3 feet to an iron pin at the joint rear corner of Lots No. 4 and 5; thence along the rear line of Lot No. 5, S. 66-24 E., 145 feet to an iron pin at the joint rear corner of Lots 5 and 6; thence along the line of Lots 5 and 6, N. 2-32 W., 282.6 feet to an iron pin on Bayne Road; thence along Bayne Road, S. 86-54 W., 120 feet to the point of beginning.

To Have and to Hold unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate in the event this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any easements and restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.

Uniform Covenants. Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest. Borrower shall promptly pay when due the principal of and interest on the indebtedness evidenced by the Note, prepayment and late charges as provided in the Note, and the principal of and interest on any Future Advances secured by this Mortgage.
