NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, on the northeastern side of Lambourn Way, and being known and designated as Lot No. 74 on Plat of Kingsgate, Sheet I, as recorded in the RMC Office for Greenville County in Plat Book "WWW", at Pages 44 and 45. Said lot fronts 125 feet on the northeastern side of Lambourn Way and runs back to a depth of 162.5 feet on the northern side and to a depth of 163.2 feet on the southern side and is 125 feet across the rear.

ALSO all that piece, parcel or lot of land in Williamston Township, Anderson County, State of South Carolina, lying on the north side of the road leading from Easley to Piedmont, and bounded by lands of Herbert Fortner, lands being sold to Densel M. Bagwell, lands belonging to Boiter Cleaners and by said road. BEGINNING at an iron pin on the road leading from Easley to Piedmont; thence running N. 3-27 E. for a distance of 261.4 feet to a stake, thence S. 86-53 E. 71.1 feet to an iron pin which is in the center of a treated unnamed street; thence running S. 05-17 E. 254.7 feet to a nail cap; thence S. 88-04 W., 110.2 feet to the point of beginning. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
- (2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgage debt, whether due or not.
