Modine and Mannie Spooner by deed recorded in R. M. C. Office for Greenville County, Deed Book 34 at page 265, and having the following courses and distances, to wit:

and runs thence with the original line N. 88-15 W. 225 feet to an iron pin on the said line, thence a new line N. 10-24 W. 77.4 feet to an iron pin; thence another new line N. 85-45 E. 220.2 feet to a point in the center of the said Suber Road (iron pin back on line at 20 feet); thence with the center of said Poad S. 11-00 E. 101 feet to the beginning corner, and contining forty-five one -hundredths (0.45) of one acre, more or less.
