NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being on the northwesterly side of Robin Hood Road, being known and designated as Lot No. 260 and an adjoining part of Lot No. 259, as shown on plat entitled "Plat of Sherwood Forest", as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book GG, pages 2 and 3, and Plat Book GG, pages 70 and 71, and having according to plat and survey made by H. C. Clarkson, Jr., recorded May 26, 1969, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Robin Hood Road, the joint front corner of Lot Nos. 260 and 261; running thence with the common line of said lots N. 70-57 W. 205.41 feet to an iron pin; thence turning and running S. 12-50 W. 71 feet to an iron pin on the rear line of Lot No. 259; running thence through Lot No. 259 S. 57-35 E. 184.7 feet to an iron pin on the northwesterly side of Robin Hood Road; thence along Robin Hood Road N. 33-24 E. 30 feet to an iron pin; thence continuing along Robin Hood Road N. 26-16 E. 85 feet to the beginning corner.
