WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

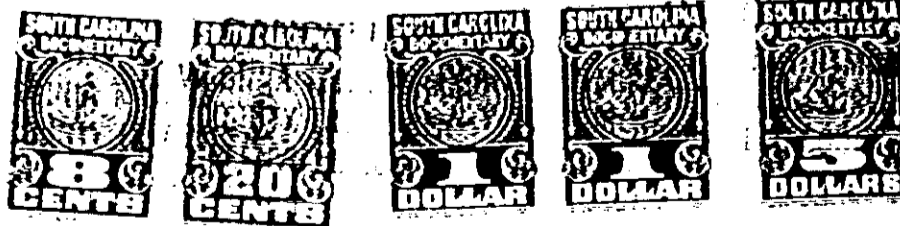

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville and being a portion of Lot 155, Sunny Slopes Subdivision, Section Two, according to that certain plat prepared of said subdivision prepared by C. O. Riddle, Surveyor, February 8, 1971 and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4R, at Page 67, and having the following courses and distances to-wit:
