It is hereby agreed that should any default be made in the payment of interest on said first to orgage, and such interest remains impaid and in arrears for ten days or should any suit be commenced to forcelose said first no rigage, then the amount secured by this mortgage and the accompanying note shall become and be due and payable at any time thereafter at the option of the owner or holder of this mortgage.

It is further agreed, generally, that said mortgaged may, at its election, advance and pay any and all sums of money that in its judgment may be necessary to perfect title of said mortgaged premises or to preserve or defend the security intended to be given by this mortgage to advance and pay any and all installments or principal or interest on any and all prior mortgage hens and any and all sums of money so advanced and paid, shall bear interest at the rate of which was originally contracted for in this instrument, and they hereby are made part of the mortgage debt hereby secured. AND IT IS AGREED, by and between the parties hereto, that the said mortgagor their heirs, executors, or administrators, shall keep the buildings crected, or to be erected on said premises, insured against loss or damage by fire, for the benefit (\$5,160.00) of the said mortgagee, for an amount not less than Five thousand one hundred sixty and 00/100 Dollars, in such company as shall be approved by the said mortgagee, and shall deliver the policy to the said mortgagee, and in default thereof,
