14. That in the event this mortgage a sould be foreclosed, the Mortgagor expressly waives the Exactits of Sections 45-88 through 15-96.1 of the 1962 Code of Laws of South Carolina, as amended, or any other appraisement laws

THE MORTGAGEE COVENANTS AND AGREES AS FOLLOWS:

- 1. That should the Mortgagor prepay a portion of the indebtedness secured by this mortgage and subsequently fail to make a payment or payments as required by the aforesaid promissory note; any such prepayment may be applied toward the missed payment or payments, insofar as possible, in order that the principal debt will not be held contractually delinquent.
