entry of a judgment enforcing this Mongage if: (a) Borr wer pays Lender all sums which would be then due under this Mongage, the Note and it tes securing Future Advances, if any, had no acceleration occurred; (b) Borower cures all breaches of any other covenants or agreements of Borrower contained in this M (tgage), (c) Borrower pays all reasonable expenses incurred by Lender in enforcing the covenants and agreements of Borrower contained in this Mortgage and in enforcing Lender's remedies as provided in paragraph 18 hereof, including, but not limited to, reasonable attorney's fees; and (d) Barower takes such action as Lender may reasonably require to assure that the lien of this Mortgage, Lender's interest in the Property and Bartower's obligation to pay the sums secured by this Mortgage shall continue unimpaired.
