Office for Greenville County in Plat Book 00, at Pages 66 and 67, and being also known and designated as Lot No. 34 and the Southwestern one half of lot No. 33 as shown on a subsequent revision of said plat which is not yet recorded and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint rear corner of lot No. 23 and 24 as shown on the above mentioned plat recorded in Plat Book 00, at pages 66 and 67 and running thence along the joint line of Lots No. 34 and 35 as shown on the revised Plat, C. 34-35 N. 145 feet to a nail cap in the center of the Old Farris Bridge Road; thence in the center of said road; thence continuing along the center of said road, N. 46 E. 66 feet to a nail cap at the joint front corner of Lots No. 33 & 34 as shown on the revised plat; thence continuing with the center of said road, N. 46 E. 52.5 feet to a nail cap in the center of the front line of lot No. 33 thence along a new line through the center of lot No. 33 N. 36-36 E. 145 feet more or less, to a point in the center of

Mortgagor agrees to pay all taxes, fees, assessments, obligations, prior encumbrances, and any charges whatsoever against the above described real estate as they become due. Mortgagor also agrees to maintain insurance in such form and amount as may be satisfactory to Mortgagee in Mortgagee's favor.
