WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Thirty-Five Thousand Six Hundred and No/100-----** DOLLARS

(\$ 35,600.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is **30** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

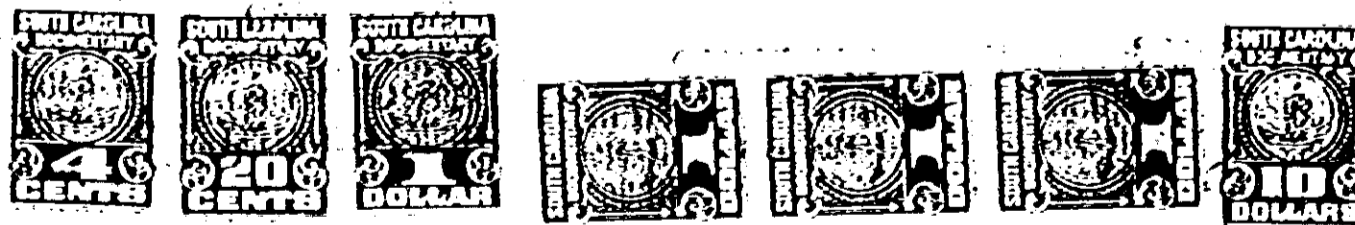

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located on the east side of Pimlico Road, in the City of Greenville, shown as Lot No. 507, on Plat of Section D, of Gower Estates, made by R. K. Campbell and Webb Surveying and Mapping Co., May 1964, recorded in the R.M.C. Office, for Greenville County, S. C., in Plat Book RR, at Pages 192 and 193, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Pimlico Road, at the joint corners of Lots 506 and 507 and runs thence along the line of Lot 506 S. 87-55E. 140 feet, to an iron pin; thence with the line of Lot 505 S. 62-25 E. 92 feet to point in center of branch; thence along the center of the branch (the traverse line being S. 29-02 W. 84.2 feet) to a point in center of branch, at the joint rear corners of Lots 507 and 508; thence along the line of Lot 508 N. 87-25 W. 190 feet, to an iron pin on the east side of Pimlico Road; thence along Pimlico Road N. 2-35 E. 108 feet to the beginning corner.
