MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Emmett Walker, Jr. and Shelby L. Walker

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mertgagee) in the full and just sum of Twenty-Nine

Thousand Nine Hundred Twenty-Four and 68/100----- (\$ 29,924.68)

Dollars as evidenced by Mortzagor's premissory note of even date herewith, which note does not have a provision for escalation of interest rate (paragraphs 9 and 10 of this mertgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Two Hundred

Forty-Eight and 81/100----- .5 248.81 FOREY-Eight and 81/100------ (5 248.81 ) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on impaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 26 years after date, and

WHEBEAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortzagee, or any stipul decases tout in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said hobler shall have the right to institute any proceedings upon said note and any collaterals given to secure since, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings, and

WHEREAS, the Mentargor may hereafter become inhibited to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose,

NOW. KNOW ALL MEN. That the Mortzagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortzagor to the Mortzagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and tridy paid by the Mortzagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant bargain, sell and release unto the Mortgagor, its successors and assigns, the following described real estate.

All that certain piece, parcel or lot of find with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot #50 on plat of Old Mill Estates, Section II, made by Piedmont Engineers and Architects, June 15, 1972 and recorded in the RMC Office for Greenville County in Plat Book 4R at Page 22. A reference is hereby made to said plat for a more complete description.

BEGINNING at an iron pin on Eastwood Drive at the joint front corner of Lots 49 and 50 and running thence along the joint line of said lots N. 3-51 W. 200.0 feet to an iron pin; thence N. 8-00 E. 109.1 feet to an iron pin in the joint rear corner of Lot 51; thence with line of said lot S. 4-12 E. 211.9 feet to an iron pin on Eastwood Drive; thence with said Drive S. 86-09 W. 110.0 feet to an iron pin, the point of beginning.
