All that certain piece, parcel or lot of land, situate, lying and being in Greenville County, South Carolina, containing 1.2 acres more or less and being part of property of F. O. Barbare, deeded to J. B. Taylor and Joan B. Taylor by Deed of September 26, 1961, recorded May 12, 1962, in Deed Book 698 at Page 103, in the R.M. C. Office for Greenville County South Carolina, and having, according to said deed the following metes and bounds, to wit:

Beginning at an point in S. C. Highway #414, about 2 miles East of Highland running thence N. 33-05 W., passing iron pin at 27.3 feet and with Cleona Morton line 178.1 feet to iron pin thence New line N. 11-10 W., 269 feet to iron pin, thence S. 67-12 E., 132 feet to iron pin, thence S. 30-27 E., 62 feet to iron pin, thence S. 10-13 E., 74 feet to iron pin, thence S. 38-44 E. 187 feet passing iron pin at 16.3 feet to point in said Highway thence with same S. 56-17 W., 161.4 feet to the beginning.
