(14) The Covernment may extend and defer the maturity of and renew and reamortize the debt evidenced by the note or any indebtedness to the Government secured hereby, release from liability to the Government any party so liable thereon, release portions of the property from and subordinate the lien hereof, and waive any other rights hereunder, without affecting the lien or priority hereof or the liability of the Government of Borrower or any other party for payment of the note or indebtedness secured hereby except as specified by the Government in

(21) This instrument shall be subject to the present regulations of the l'armers Home Administration, and to its future regulations not
