(6) That if there is a default in any of the terms, conditions, or covenants of this mortgage, or tof the note secured hereby, then, at the option of the Mortgagee, all sums then owing by the Mortgages to the Mortgagee shall become immediately due and payable, and this mortgage may be foreclosed. Should any legal proceedings be instituted for the fereclosure of this mortgage, or should the Mortgagee become a party of any suit involving this mortgage or the title to the premises described berein, or should the debt secured hereby or any part thereof be placed in the hands of any attorney at law for collection by suit or otherwise, all costs and expenses incurred by the Mortgagee, and a reasonable attorney's fee, shall thereupon become due and payable immediately or on demand, at the option of the Mortgagee, as a part of the debt secured hereby, and may be recovered and collected hereunder.
