"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being on the Southern side of Terrace Lane, being known and designated as Lots 6 and 7 of Terrace Acres Subdivison, plat of which is recorded in the R.M.C.
