That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 2 as shown on plat of Pilgrim's Point, recorded in plat book 4-R page 69 of the RMC Office for Greenville County, and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the east side of the turn-around of Freeport Drive, joint front corner of Lots 2 & 3, and running thence with the joint line of said lots N. 81-23 E. 113.3 feet to an iron pin in the line of property of L. W. McCrary; thence with the line of said property S. 18-55 E. 135 feet to an iron pin in line of Lot No. 1; thence with the joint line of lots 1 & 2, N. 85-54 W. 211.7 feet to an iron pin in line of lot No. 19; thence with the line of said lot N. 17-50 W. 85 feet to an iron pin on the south side of Freeport Drive; thence with the curve of the turn-around of said street, the traverse line of which is S. 65-35 E. 35 feet to a point; thence  $\hat{N}$ . 76-57 E. 30 feet to a point; thence continuing with the curve of said turn-around N. 41-54 E. 30 feet to the point of beginning.
