"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that lot of land situate on the north side of Alta Vista Circle, near the Town of Travelers Rest, in Greenville County, South Carolina, being shown as Lot 162 and the western portion of Lot 161 on plat of Addition to Coleman Heights, recorded in the RMC Office for Greenville, S. C. in Plat Book RR, Page 161, and having, according to said plat, the following metes and bounds, to-wit:
