TO ALL WHOM THESE PRESENTS MAY CONCERN:

SEND GREETINGS:

WHEREAS, we the said Carl David Hill and Evelyn Hill, hereinafter called Mortgagor, in and by our certain Note or obligation bearing even date herewith, stand indebted, firmly held and bound unto THE CITIZENS AND SOUTHERN NATIONAL BANK OF SOUTH CAROLINA, hereinafter called Mortgagee, in the full and just principal sum of Twenty-Five Thousand and No/100-----Dollars (\$25,000.00----), with interest thereon payable in advance from date hereof at the rate of nine (9%) per annum; the principal of said note together with interest being due and payable in (60) -----  
Number

Monthly installments as follows:  
(Monthly, Quarterly, Semiannual or Annual)  
Beginning on July 10, 1976, and on the same day of each monthly period thereafter, the sum of Five Hundred Eighteen and 96/100----- Dollars (\$518.96-----)

and the balance of said principal sum due and payable on the 10th day of June, 1981.  
Interest only payable on amounts advanced at 9% until July 10, 1976.

The aforesaid payments are to be applied first to interest at the rate stipulated above and the balance on account of unpaid principal. Provided, that upon the sale, assignment, transfer or assumption of this mortgage to or by a third party without the written consent of the Bank, the entire unpaid balance of the note secured by this mortgage, with accrued interest, shall become due and payable in full or may, at the Bank's option, be continued on such terms, conditions, and rates of interest as may be acceptable to the Bank.

Said note provides that past due principal and/or interest shall bear interest at the rate of \_\_\_\_\_% per annum, or if left blank, at the maximum legal rate in South Carolina, as reference being had to said note will more fully appear; default in any payment of either principal or interest to render the whole debt due at the option of the mortgagee or holder hereof. Forbearance to exercise this right with respect to any failure or breach of the maker shall not constitute a waiver of the right as to any subsequent failure or breach. Both principal and interest are payable in lawful money of the United States of America, at

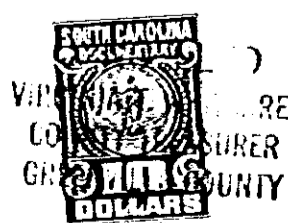
the office of the Mortgagee in Greenville, South Carolina, or at such other place as the holder hereof may from time to time designate in writing.

NOW, KNOW ALL MEN, that the said Mortgagor in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said Note; and also in consideration of the further sum of THREE DOLLARS, to the said Mortgagor in hand well and truly paid by the said Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents DO GRANT, bargain, sell and release unto the said Mortgagee the following described real estate, to-wit:

All that certain piece, parcel, or tract of land in the County of Greenville, State of South Carolina, on the westerly side of U. S. Highway I-85 and being shown and designated as Property of Carl D. Hill and Evelyn C. Hill, on plat prepared by C. O. Riddle, RLS, January 1, 1976, said tract containing 6.56 acres, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the westerly side of U. S. Highway I-85, the extreme northeasterly corner of the property herein described, and running thence along said Highway the following courses and distances: S. 22-45 W. 489.9 feet to a concrete monument; thence N. 66-34 W. 10.3 feet to a concrete monument; thence S. 23-02 W. 101.6 feet to a concrete monument; thence leaving said Highway and running S. 76-41 W. 525.8 feet to an iron pin; running thence N. 22-40 E. 19.3 feet to an iron pin; running thence N. 14-48 E. 567.5 feet to an iron pin; running thence N. 80-54 E. 603 feet to the point of BEGINNING.
