"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lots 73 and 74 of Edwards Forest Heights on plat prepared in 1967 by Jones Engineering Service and recorded in Plat Book 000 at Page 87 in the R.M.C. Office for Greenville County, said lots being more fully described as follows:

BEGINNING at an iron pin at the joint front corner of Lots 72 and 73, said iron pin lying on the southern line of Old Mill Road and running S. 15-02 W. 200 feet to an iron pin at the joint rear corners of Lots 72 and 73; thence S. 67-07 E. 110.7 feet to an iron pin at the joint rear corner of Lots 73 and 74; thence S. 63-43 E. 50 feet to an iron pin at the joint rear corner of Lots 74 and 75; thence N. 39-45 E. 190.7 feet to an iron pin at Old Mill Road; thence with the edge of Old Mill Road, said road being the line, N. 35-24 W. 32 feet; thence N. 55-14 E. with the curve of Old Mill Road, 94.3 feet to an iron pin; thence N. 74-58 W. 14.1 feet to an iron pin at the joint front corner of Lots 73 and 74; thence N. 74-58 W. 110 feet to the beginning point.
