"ALL that piece, parcel or lot of land located in the County, of Greenville, State of South Carolina, situate on the north side of Beck Avenue, and being known and designated as Lot 108 on plat of Augusta Road Ranches, Property of Sarah R. Beck, dated April, 1941, prepared by Dalton & Neves, Engineers, and recorded in the R.M.C. Office for Greenville County, in Plat Book M. at Page 47, and having according to said plat, the following metes and bounds, to-wit:
