(6) That if there is a default in any of the terms, conditions, or coverants of this mortgage, or of the note secured hereby, then, at the option of the Nortgagee, all sums then owing by the Mortgager to the Mortgagee shall become namediately due and payable, and this mortgage may be foreclosed.
