TOCETHER with all and singular the rights, members, hereditanents and appartenances to the same belonging or in any was incident or appertaining, including all built-in stoves and refrigerators beating air conditioning, planding and electrical fixtures wall to wall carpeting, fences and gates and any other equipment or fixtures new or hereafter attached connected or fitted in any manner, it being the intention of the parties hereto that all such futures and equipment, other than household furniture, be considered a part of the realty.

TO HAVE AND TO HOLD all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor represents and warrants that said Mortgagor is seized of the above described premises in fee simple absolute; that the above described premises are free and clear of all hers or other enoundrances; that the Mortgagor is lawfully empowered to convey or encumber the same, and that the Mortgagor will focuse defend the said premises unto the Mortgagoe, its successors and assigns, from and against the Mortgagor and every person whomsoever lawfully claiming or to claim the same or any part thereof.

THE MORTGACOR COVENANTS AND AGREES AS FOLLOWS:

- 1. That the Mortgagor will promptly pay the principal and interest on the indebtedness evidenced by said promissory note at the times and in the manner therein provided.
- 2. That this mortgage will secure the Mortgagee for any additional sums which may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, or public assessments, hazard insurance premiums, repairs or other such purposes pursuant to the Mortgage, and also for any loans or advances that may hereafter be made by the Mortgagee to the Mortgager under the authority of Sec. 45-55, 1962 Code of laws of South Carolina, as amended, or similar statutes, and all sums so advanced shall bear interest at the same rate or rates as that provided in said note unless otherwise agreed upon by the parties and shall be payable at the demand of the Mortgagee, unless otherwise provided in writing.
- 3. That Mortgagor will keep the improvements on the mortgaged premises, whether now existing or hereafter to be erected, insured against his by fire, windstorm and other hazards in a sum not less than the balance due hereunder at any time and in a company or companies acceptable to the Mortgagee, and Mortgagor does hereby assign the policy or policies of insurance to the Mortgagoe and agrees that all such policies shall be held by the Mortgagoe should it so require and shall include loss payable clauses in favor of the Mortgagoe; and in the event of loss. Mortgagor will give immediate notice thereof to the Mortgagoe by registered trial, and should the Mortgagor at any time fail to keep said premises insured or fail to pay the premiums for such insurance, then the Mortgagoe may cause such improvements to be insured in the name of the Mortgagor and reindourse itself for the cost of such insurance, with interest as hereinal-one provided.
- 4. That the Mortgagor will keep all improvements upon the mortgaged premises in good repair, and should Mortgagor fail to do so, the Mortgagor may, at its option, enter upon said premises and make whatever repairs are necessary and charge the expenses for such repairs to the mortgage debt and collect the same under this mortgage, with interest as hereinabove provided.
- 5. That the Motgazee may at any time require the issuance and maintenance of insurance upon the life of any person obligated under the indebtedness secured hereby in a sum sufficient to pay the motgage debt, with the Mottgagee as beneficiary, and if the premiums are not otherwise paid, the Mottgagee may pay said premiums and any amount so paid shall become a part of the mortgage debt.
- 6. That Mortgager agrees to pay all taxes and other public assessments levied against the mortgaged premises on or before the due dates thereof and to exhibit the receipts therefor at the offices of the Mortgagee immediately upon payment, and should the Mortgager fail to pay such taxes and assessments when the same shall fall due, the Mortgagee may, at its option, pay the same and charge the amounts so paid to the mortgage debt and collect the same under this mortgage, with interest as above provided.
- 7. That if this mortgage secures a "construction lam", the Mortgage agrees that the principal ansount of the indebtedness hereby secured shall be discursed to the Mortgager in periodic payments, as construction progresses, in accordance with the terms and conditions of a Construction Loan Agreement which is separately executed but is made a part of this mortgage and incorporated herein by reference.
- 8. That the Mortgagor will not further encumber the premises above described, without the prior consent of the Mortgagor, and should the Mortgagor so encumber such premises, the Mortgagor may, at its option, declare the indebtedness hereby secured to be immediately due and payable and may institute any proceedings necessary to collect said indebtedness.
- 9. That should the Mortzarer alienate the mortzared premises by Contract of Sale. Bond for Title, or Deed of Conveyance, and the within mortgaze irrelatedness is not paid in full, the Mortzarer or his Purchaser shall be required to file with the Association an application for an assumption of the mortgaze indebtedness, pay the reasonable cost as required by the Association for processing the assumption furnish the Association with a copy of the Contract of Sale, Bond for Title, or Deed of Conveyance, and have the interest rate on the lean balance existing at the time of transfer modified by increasing the interest rate on the said bun balance to the maximum rate per anomal permitted to be charged at that time by applicable South Carolina law, or a lesser increase in interest rate as may be determined by the Association. The Association will notify the Mortzaror or his purchaser of the new interest rate and monthly payments and will mad him a new pusheols. Should the Mortzaror, or his Purchaser, full to comply with the provisions of the within paragraph, the Mortzaroe, at its option, may declare the indebtedness hereby secured to be immediately due and payable and may institute any proceedings necessary to collect said indebtedness.
- 10. That should the Mortgagor ful to make payments of principal and interest as due on the promissory note and the same shall be unpaid for a period of thirty (30) days, or if there should be any failure to comply with and abide by any by-laws or the charter of the Mortgagoe, or any stipulations set out in this mortgage the Mortgagoe at its option may write to the Mortgagor at his last known address giving him thirty (30) days in which to rectify the said default and should the Mortgagor ful to rectify said default within the said thirty days the Mortgagoe, may, at its option, increase the interest rate on the Fan balance for the remaining term of the kun or for a lesser term to the maximum rate per arrown permitted to be charged at that time by applicable South Carolina law, or a lesser increase rate as may be determined by the Association. The monthly payments will be adjusted accordingly.
- 11. That should the Mortgares full to make payments of principal and interest is due on the promissory note and should any monthly installment become past due for a period in excess of 15 days, the Mortgagee may collect a "late charge" not to exceed an amount equal to five (5%) per centum of any such past due installment in order to cover the extra expense incident to the handling of such deligonest payments.
- 12. That the Mortgagor hereby assigns to the Mortgagee, its successors and assigns all the rents issues, and profits accoming from the mortgaged premises retaining the right to collect the same so long as the debt hereby secured is not in anears of payment, but should any part of the principal indebtodness, or interest, taxes, or fire insurance premiums, he past due and unpaid, the Mortgagee may without rotice or further proceedings take over the mortgaged premises, if they shall be occupied by a tenant or tenants, and collect said rents and profits and apply the same to the indebtodness hereby secured, without hiddlety to account for anything more than the rents and profits actually collected, less the cost of collection, and any tenant is authorized upon repost by Mortgagee, to make all rental payments direct to the Mortgagee without hiddlety to the Mortgager until rotified to the contrary by the Mortgagee; and should said premises at the time of such default be occupied by the Mortgager, the Mortgagee may apply to the Judge of the County Court or to any Judge of the Count of Common Pleas who shall be resident or presiding in the county aforesail for the appointment of a receiver with authority to take possession of said premises and collect such rents and profits, applying said rents, after paying the cost of collection, to the mortgage debt without hability to account for anything more than the rents and profits actually collected.
- 13. That the Mortgagee, at its option, may require the Mortgagor to pay to the Mortgagee, on the first day of each mosth until the note secured berdy is fully paid, the following sums in addition to the payments of principal and interest provided in said rote: a sum equal to the premiums that will next become due and payable on policies of mortgage guaranty insurance (if applicable), fire and other hazard insurance covering the mortgaged property, plus taxes, and assessments next due on the mortgaged premises (all as estimated by the Mortgagee) less all sums already paid therefor, divided by the number of months to clapse before one mouth prior to the date when such premiums, taxes, and assessments will be due and payable, such sums to be held by Mortgagee to pay soid premiums, taxes and special assessments. Should these payments exceed the amount of payments actually made by the Mortgagee for taxes, assessments, or insurance premiums, the excess may be credited by the Mortgagee on subsequent payments to be made by the Mortgagor if, however, said sums shall be insufficient to make said payments when the same shall become due and payable, the Mortgagor shall pay to the Mortgagee any amounts recessary to make up the deficiency. The Mortgagor further agrees that at the end of ten years from the date hereof. Mortgagee may, at its option, apply for renewal of mortgage guaranty or similar insurance (if applicable) covering the balance then remaining due on the mortgage debt, and the Mortgagor may, at its option, pay the single promium required for the remaining them on the Mortgager may pay such premium and add the same to the mortgage debt in which event the Mortgagor shall repay to Mortgagee such premium payment, with interest, at the rate specified in said promissory tote, in equal monthly installments over the remaining payment period.
