TO ALL WHOM THESE PRESENTS MAY CONCERN:

James Richard Webb and Mary Jo K. Webb,
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Forty Thousand and 00/100-----

DOLLARS (\$ 40,000.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

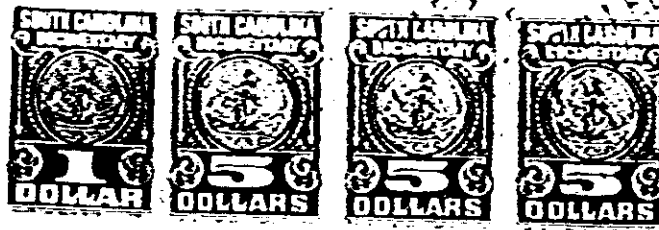

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 69 on a plat of Huntington, Sheet No. 4, which plat was prepared by Piedmont Engineers and Architects, and is of record in the RMC Office for Greenville County in Plat Book WW-26, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Huntington Road at the joint front corner of Lots 68 and 69, and running thence with said Road S. 84-23 E. 127.65 feet to a point; thence continuing with said Road S. 74-56 E. 121.2 feet to an iron pin on Huntington Road at the joint front corner of Lots 69 and 70; thence with the common line of Lots 69 and 70 S. 0-11 E. 290.26 feet to an iron pin, joint rear corner of Lots 69 and 70; thence with the rear line of Lot 69 S. 79-55 W. 240.0 feet to an iron pin at the joint rear corner of Lots 68 and 69; thence with the common line of Lots 68 and 69 N. 1-20 W. 376.06 feet to an iron pin on the southern side of Huntington Road, the point of beginning.
