All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of

All that piece, parcel or lot of land situate, lying and being on the Northern side of Third Day Street near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 56 as shown on a plat of Canterbury Subdivision, Section I, prepared by Heaner Engineering Co., Inc., dated March 22, 1972, and recorded in the R.H.C. Office for Greenville County, South Carolina, in Plat Book 4-N at page 69 and being also known and designated as Lot No. 56 on a revision of said subdivision plat prepared by Heaner Engineering Co., Inc., revised through April 24, 1974, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 5-D at page 52 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Third Day Street at the joint front corner of Lots Nos. 55 and 56 and running thence with the line of Lot No. 55 N. 15-16-25 W. 111.94 feet to an iron pin; thence with the rear line of Lot No. 59 S. 77-08-00 W. 80 feet to an iron pin at the joint rear corner of lots Nos. 56 and 57; thence with the line of Lot No. 57 S. 18-08-29 E. 118.66 feet to an iron pin on the Northern side of Third Day Street; thence with the Northern side of Third Day Street N. 71-51-31 E. 55.76 feet to an iron pin; thence continuing with the curve of the Northern side of Third Day Street, the chord of which is N. 73-23-32 E. 18.30 feet to the point of beginning.
