thereon situated in South Carolina, County of Greenville
 BEGINNING at an iron pin on the northeastern side of Lullwater Road, joint front corner of Lots No. 29 and 30 and running thence with the common line of said Lot N. 48-52 E. 245.6 feet to an iron pin; thence with the rear line of Lot no. 30 S. 35-45 E. 105.4 feet to an iron pin at the joint rear corner of Lots No. 30 and 31; thence with the common line of said lots S. 48-52 W. 236.1 feet to an iron pin on the northeastern side of Lullwater Road; thence with said road N. 41-08 W. 105 feet to iron pin; the point of beginning.
