MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Isaac Newton Patterson, Jr., of the County of Greenville, State of South Carolina, - - - - SEND GREETING:

WHEREAS, I, the said Isaac Newton Patterson, Jr., - - - - -

in and by, my certain promissory note, in writing, of even date with these presents am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF ANDERSON, of the County and State aforesaid, a body corporate under the laws of the United States, in full and just sum of Fifteen Thousand and No/100 - - - - - (\$ 15,000.00) Dollars with interest at the rate of Eight & Three-Fourths ^(8 3/4%) per centum per annum, to be repaid in installments of One Hundred Forty-Nine and 92/100 - - - - - (\$ 149.92) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed and paid monthly in advance on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

All that certain lot of land in Greenville Township, Greenville County, State of South Carolina, on the Northern side of Beck Avenue in the City of Greenville, being the Western one-half of Lot Number One Hundred Three (103) and the Eastern one-half of Lot Number One Hundred Two (102) as shown on plat of Augusta Road Ranches made by Dalton & Neves, in April, 1941, as revised in April, 1942, recorded in Plat Book "M" at page 47, in the Office of the Register of Mesne Conveyances for Greenville County, South Carolina, and described as follows: BEGINNING at a stake on the Northern side of Beck Avenue two hundred fifty-five and nine-tenths (255.9) feet East from Long Hill Street, and running thence North 00 degrees 13 minutes West one hundred ninety-five and three-tenths (195.3) feet to stake, thence North 72 degrees 28 minutes East sixty-two and eight-tenths (62.8) feet to stake, thence South 00 degrees 13 minutes East two hundred fourteen and five one-hundredths (21405) feet to stake on Beck Avenue, thence with the Northern side of Beck Avenue South 89 degrees 47 minutes West sixty (60) feet to the beginning corner; being the same lot of land conveyed to mortgagor herein by deed of James V.
