


First Mortgage on Real Estate

MORTGAGE

STATE OF SOUTH CAROLINA COUNTY OF GREENVILLE





(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, March, 2002.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the northern side of The's Road in the County of Greenville, State of South Carolina, being shown as a tract containing 1.12 acres on a plat of the property of Franklin Enterprises, Inc. dated August, 1975, prepared by C. O. Riddle, Surveyor, recorded in Plat Book 5-H at Page 149 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Ike's Road at the joint front corner of a 1.31 acre tract and a 1.12 acre tract and running thence with the said 1.31 acre tract N. 14-00 E. 208 feet to an iron pin at the joint rear corner of said 1.31 acre tract and a 1.12 acre tract; thence S. 76-14 E. 64.1 feet to an iron pin; thence S. 75-46 E. 101.3 feet to an iron pin; thence S. 12-10 W. 281.3 feet to an iron pin on the northern side of I'te's Road; thence with said Road N. 79-31 W. 114.4 feet to an iron pin; thence still with said road N. 84-35 W. 61.4 feet to the point of beginning.

This is a portion of the property conveyed to the mortgagor by deed recorded in Deed Book 1023 at Page 203 in the R.M.C. Office for Green-ville County.
