MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Southland Properties, Inc.

thereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagoe) in the full and just sum of

Thirty-five thousand two hundred and no/100ths-----(\$ 35,200.00)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Two hundred seventy-

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern corner of Howell Circle and Ayrshire Drive near the City of Greenville, being known and designated as Lot 3 of Section 2, of a subdivision known as Spring Forest as shown on a plat thereof recorded in the RMC Office for Greenville County in Plat Book BBB at Page 34 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northwestern corner of Howell Circle and Ayrshire Drive and running thence with the northern side of Ayrshire Drive, S 66-30 W 115 feet to an iron pin at the corner of Lot 4, thence with the line of said lot, N 23-30 W 140 feet to an iron pin in the line of Lot 2; thence with the line of said lot, N 66-30 E 140 feet to an iron pin on Howell Circle; thence with the western side of said Circle, S 23-30 E 115 feet to an iron pin at the corner of Ayrshire Drive; thence with the curve of the intersection of Howell Circle and Ayrshire Drive, the chord of which is S 21-30 W 35.35 feet to the point of beginning.
