NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to the above named Mortgagee in the above Total of Payments and all future and other obligations of Mortgagor to Mortgagee, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all present and future improvements thereon situated in South Carolina, County of

Greenville

ALL that certain piece, parcel or lot of land lying and being in the easterly side of Elaine Avenue (formerly Kessler Street) near the City of Greenville, South Carolina, and being shown as Lot No. 21 on the Plat of Pine Brook as recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "Z", page 148, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Elaine Ave., joint front corner of Lots 21 & 23, and running thence along the common line of said lots N. 56-29 E. 150 feet to an iron pin: thence S. 33-31 E. 75 feet to an iron pin, joint rear corner of Lots 19 & 21; thence along the common line of said lots S. 56-20 W. 150 feet to an iron pin on the easterly side of Elaine Ave.: thence along said Avenue N. 33-31 W. 75 feet to the point of beginning.

TO HAVE AND TO HOLD all and singular the real estate described above unto said Mortgagee, its successors and assigns forever.

If Mortgagor shall fully pay according to its terms the indebtedness hereby secured then this mortgage shall become null and void.

Mortgagor agrees to pay all taxes, Ears, assessments, obligations, prior encumbrances, and any charges whatsoever against the above described real estate as they become due. Upon any default, all obligations of Mortgagor to Mortgagee shall become due, at the option of Mortgagee, without notice or demand.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed and any court costs which shall be secured by this mortgage and included in judgment of foreclosure.

This mortgage shall extend, consolidate and renew any existing mortgage held by Mortgagee against Mortgagor on the above described real estate.
