"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and according to a plat prepared by William Eaton, Jr., dated September 3, 1974 entitled "Property of Mrs. Willie M. Phillips" has the following metes and bounds, to-wit:

BEGINNING at a point in the center of West Road at a point approximately 350 feet from U. S.
