**SEND GREETING:**

WHEREAS, the said M. Starzel Vorp and Shirley V. Vorp  
in and by our certain promissory note in writing of even date with these Presents are well  
and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of  
Three Thousand Six Hundred and Ninety Dollars (\$ 3,600.00) Dollars,  
with interest from the date hereof at the rate of five per cent (5%) per annum, unpaid interest to  
bear interest at the same rate, to be repaid in installments of Fifty seven and 93/100 -----

( \$ 57.03 ) Dollars

due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

**KNOW ALL MEN BY THESE PRESENTS.** That we the said M. Stansel Yamp  
and Shirley N. Yamp, in consideration of the said debt and sums of money  
aforesaid, and for the better securing the payment thereof to the said CITIZENS BANCORP AND LOAN ASSOCIATION,  
Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00)  
Dollars to us the said mortgagors in hand well and truly paid by the said mortgagee, at and  
before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained,  
sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BANCORP AND  
LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, located on the southwest side of the Longleaf Road and being shown on plat made for Marion S. Kamp by Jerry T. Hill, surveyor, dated August 22, 1971, and having the following metes and bounds to wit:

Beginning in the center of said road at corner of George V. Mappe and runs thence with this line, S. 37-31 E., 255 feet to front of the house on the property of W. R. McCarter, S. 25-31 W., 190.5 feet + from side of corner of Claude M. Styles' house with Styles, N. 25-30 W., 191.7 feet to the center of said road thence along the center of said road, N. 48-32 E., 149.5 feet to the beginning corner and containing 1.10 acres more or less.

P. Morris, June 15, 1956 and recorded in plan book PP page 195, Greenville County P. M. C. Office, and bearing the following notes and bounds to wit:

Beginning at an iron pin on the Northern side of said road at the joint front corner of lots 2 and 3 and running thence N. 61-20 E., 100 feet along said road to an iron pin at the joint front corner of lots 1 and 2; thence N. 28-18 W., 258 feet along line of lot No. 1 and driveway to front pin, joint rear corner of said lots; thence S. 60-50 W., 100 feet to the joint rear corner of lots 2 and 3; thence S. 28-18 E., 247 feet along the line of lot No. 3 to the beginning corner. On leaving 0.56 of an acre, more or less.
