NOW, aNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville, on the western side of Chatelaine Drive, being hown and designated as Lot 164 on that certain plat of Merrifield Park, Section 1, prepared by C. O. Riddle, Surveyor, dated October, 1967, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 000, at page 277 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin at the joint front corner of Lots 164 and 165 on the right of way for Chatelaine beard and running thence N. 68-16 W. 226.4 feet along the joint side line of Lots 164 and 165 to the joint rear corner of Lots 164 and 165; thence N. 8-42 E. 55.8 feet to an iron pin at the joint rear corner of Lots 164 and 163; thence with the joint side line of Lots 164 and 163 S. 88-20 E. 228.7 feet to the joint front corner of Lots 164 and 163; thence with the right of way for Chatelaine Drive, the chord of which is S. 1-40 W. 55.2 feet to an iron pin; thence continuing with the right of way for Chatelaine Drive, the chord of which is S. 12-40 W. 79.8 feet to the point of beginning.
