\*ALL that certain piece, parcel or ter ef land, with all improvements thereon, or hereafter constructed thereon, situate, trying and being in the State of South Carolina, County of Greenville, and being known and designated as Tracts Nos. 2, 3, 4 and 5 as shown on plat of Property of C. B. and Clara M. Hembree in O'Neal Township, Greenville County, South Carolina, according to a survey made by H. S. Brockman, Engineer, July 23, 1959, and having according to said plat the following courses and distances, to-wit:
