All that certain piece, parcel or lot of land in the City of Greer, Chick Springs Township, County of Greenville, State of South Carolina, on the north side of Wade Hampton Boulevard, being shown and designated as <a href="Iract No. B">Iract No. B</a> on a plat of Burgiss Hills, Section 4, prepared by H. S. Brockman, Registered Surveyor, on March 24, 1966, and as amended on May 4, 1966, and recorded in the RMC Office for Greenville County in Plat Book BBB, Page 190, and having, according to said plat, the following courses and distances, to-wit:

Beginning at an iron pin on the north margin of the right of way of U. S. Highway No. 29, the joint front corner with Tract A on said plat and running thence with the common line of Tracts A and B, N. 21-20 M. 342.5 feet to an iron pin on the line of Section 3 of Burgiss Hills; thence with said line, N. 70-36 E. 400.6 feet, more or less, to an iron pin, the joint rear corner of Tracts B and C; thence with the common line of said Tracts, S. 21-20 M. 329 feet to an iron pin on the north margin of the right of way of U. S. Highway No. 29; thence with the north margin of the right of way of U. S. Highway No. 29, S. 68-40 M. 400 feet to an iron pin, the beginning corner.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever

The Mortgagor covenants that it is lawfully seized of the premises bereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liers and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing
- (2) That it will keep the improvements new existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the halance owing on the Mortgage debt, whether due or not.
