MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Whereas: **Walter Tollison and Linda M. Tollison**

hereinafter referred to as Mortgagors, well and truly indebted unto **Cryovac Employees Federal Credit Union**

hereinafter referred to as Mortgagee, as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Eight Thousand Two Hundred Sixty Eight and 00/100----** \$8,268.00-- due and payable

first to interest at One Hundred Eighteen and 65/100 (\$118.65) per month for One Hundred Twenty (120) months beginning June 15, 1976.


with interest thereon from date at the rate of **one (1)** per centum per annum to be paid Monthly

WHEREAS, the Mortgage may hereafter be converted to the sum of \$1,000.00 for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, utility assessments, repairs, or for any other purpose.

NOW, KNOW ALL MEN, That the Mortgagors, in consideration of the premises debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagors may be indebted to the Mortgagee at any time for services made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) the Mortgagee in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and to these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain property situated in Greenville County, State of South Carolina, being and being in the State of South Carolina, County of GREENVILLE, in Fairview Township, containing **6.89 acres** according to a plat made for Lin K. McLean and Betty A. McLean by C. O. Riddle, R.L.S., dated March, 1974, and being more fully described in accordance with said plat to-wit:

BEGINNING at an iron pin on the Northern side of S. C. Highway 418, said point being 1,608.5 feet to the center of Fork Shoals Road and S. C. Highway 418 crossing; thence running N. 22-30 W. 500 feet to iron pin; thence N. 67-30 E. 600 feet to iron pin; thence S. 22-30 E. 500 feet to iron pin; thence S. 67-30 W. 600 feet to iron pin, being the point of beginning.



Together with all and singular fixtures, appurtenances, to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and in like manner to the property, premises, and lighting fixtures now or hereafter to be held connected or fitted thereto in any manner, it being the intention of the parties hereto, that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD the said premises unto the Mortgagee, its heirs, successors, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or transfer the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagee further covenants to warrant title to the above described land to the said premises unto the Mortgagee for the time stated, against the Mortgagee's full payment when the same shall pass out of the possession of the Mortgagors.
