NOW, KNOW ALL, MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly said by the Morigagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel, or lot of land situate, lying, and being on the western side of Devenger Road near the City of Greenville, County of Greenville, State of South Carolina, contining 1.47 acres, more or less, and having, according to plat entitled "Property of James M. McCorkle", dated March, 1976, prepared by C. O. Riddle, Registered Surveyor, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "5 Q", at Page 144, the following metes and bounds, to wit:

BEGINNING at an iron pin on the western side of Devenger Road, joint front corner of the premises herein described and property now or formerly of J. Curtis and Louise S. Gilstrap, and running thence with the line of property now or formerly of Gilstrap, N. 59-28 W. 359.9 feet to an iron pin on the eastern side of Phillips Lane; thence with the eastern side of Phillips Lane, N. 6-58 W. 110 feet to an iron pin at the joint rear corner of the premises herein described and property now or formerly of Patterson-Taylor Builders, Inc.; thence with the line of property now or formerly of Patterson-Taylor Builders, Inc., the following courses and distances: N. 73-37 E. 119.3 feet to an iron pin, S. 58-51 E. 308.6 feet to an iron pin on the western side of Devenger Road; thence with the western side of Devenger Road, S. 18-23 W. 175 feet to the point of BEGINNING.

Together with all and singular rights, members, hereditaments, and apportenances to the same belonging or in any way incident or appertaining, and of all the rests, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, examested, or fitted thereto in any summer; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its beirs, successors and assigns, forever,

The Mortgagor covenants that it is lawfully seized of the premises hereinalwaye described in fee simple absolute, that it has good sight and is leafully authorized to sell, counces or encumber the same, and that the premises are free and clear of all bens and encumbrances except as provided herein. The Mortgapor further coverants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever claiming the same or any part thereof.

The Mostgapor further covenients and agrees as follows:

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced bereafter, at the equion of the Mortpages, for the payment of taxes, insurance premiums, public assessments, regains or other purposes pursuant to the coverants berein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgagor by the Mortgagoe so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the anortgage delst and shall be payable on demand of the Mortgapee unless caberwise goorided in writing.
- (2). That it will keep the improvements now existing or hereafter erected on the mortgaped property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage deld, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and removals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due: and that it does herein, assign to the Mortgagee the proceeds of any policy insuring the meatraged premises and does herely authorize each insurance company concerned to make payment for a loss directly to the Mostpaper, to the extent of the balance owing on the Mostpape delts, whether due or not.
- (3) That it will keep all improvements now existing or bereafter erected in good repair, and, in the case of a construction loan, that it will continue construction until completion without interruption, and should it fail to do so, the Mortgagee may, at its option, charge the expenses for such require or the completion of such construction to the mortgage delat.
- (4) That it will quas, when due, all taxes, public assessments, and other governmental or municipal charges, fines or other impositions against the mortgaged premises. That it will comply with all governmental and municipal laws and regulations affecting the mort-
- (5) That it berely assigns all rents, issues and profits of the mortgaged premises from and after any default bereunder, and agrees that, should legal proceedings be instituted pursuant to this instrument, any judge having jurisdiction may, at Chambers or otherwise, appoint a receiver of the mortgaged premises, with full authority to take possession of the mortgaged premises and collect the rents, issues and profits, including a reasonable rental to be fixed by the Court in the event said premises are occupied by the mortgager and after deducting all charges and expenses attending such proceeding and the execution of its trust as receiver, shall apply the residue of the rents, issues and profits toward the payment of the delt secured hereby,
- (6) That if there is a default in any of the terms, conditions, or covenants of this mortgage, or of the note secured, then, at the option of the Mortgagee, all sums then owing by the Mortgagor to the Mortgagee shall become immediately due and payable, and this mortgage may be foreclosed. Should any legal proceedings be instituted for the foreclosure of this mortgage, or should the Mortgagen become a party of any suit involving this Mortgage or the title to the premises described herein, or should the deld secured hereby or any part thereof be placed in the hands of any attorney at law for collection, by suit or otherwise, all costs and expenses incurred by the Mortgagee, and a reasonable attorney's fee, shall thereupon become due and payable immediately or on demand, at the option of the Mortgagee, as a part of the debt secured bereby, and may be recovered and collected hereunder.
