Lender's written agreement or applicable law. Borrower shall pay the ansoint of all mortgage insurance premiums in the

manner provided under paragraph 2 hereof.

Any amounts dishursed by Lender pursuant to this paragraph. It with interest thereon, shall become additional indebtedness of Botrower secured by this Morrpage. Unless Botrower and Lender agree to other terms of payment, such amounts shall be payable upon notice from Lender to Botrower requesting payment thereof, and shall bear interest from the date of dishurtement at the rate payable from time to time on outstanding principal under the Note unless payment of interest at such rate would be contrary to applicable law, in which event such amounts shall bear interest at the highest rate permissible under applicable law. Nothing contained in this paragraph. I shall require Lender to incur any expense or take any action bereunder.

All covenants and agreements of Borrower shall be joint and several. The captions and headings of the paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define the provisions hereof.

14. Notice. Except for any notice required under applicable law to be given in another manner. (a) any notice to Borrower provided for in this Mortgage shall be given by muting such notice by certified mail addressed to Borrower at the Property Address or at such other address as Borrower may designate by notice to Lender as provided herein, and (b) any notice to Lender shall be given by certified mail, return receipt requested, to Lender's address stated herein or to such other address as Lender may designate by notice to Borrower as provided herein.
