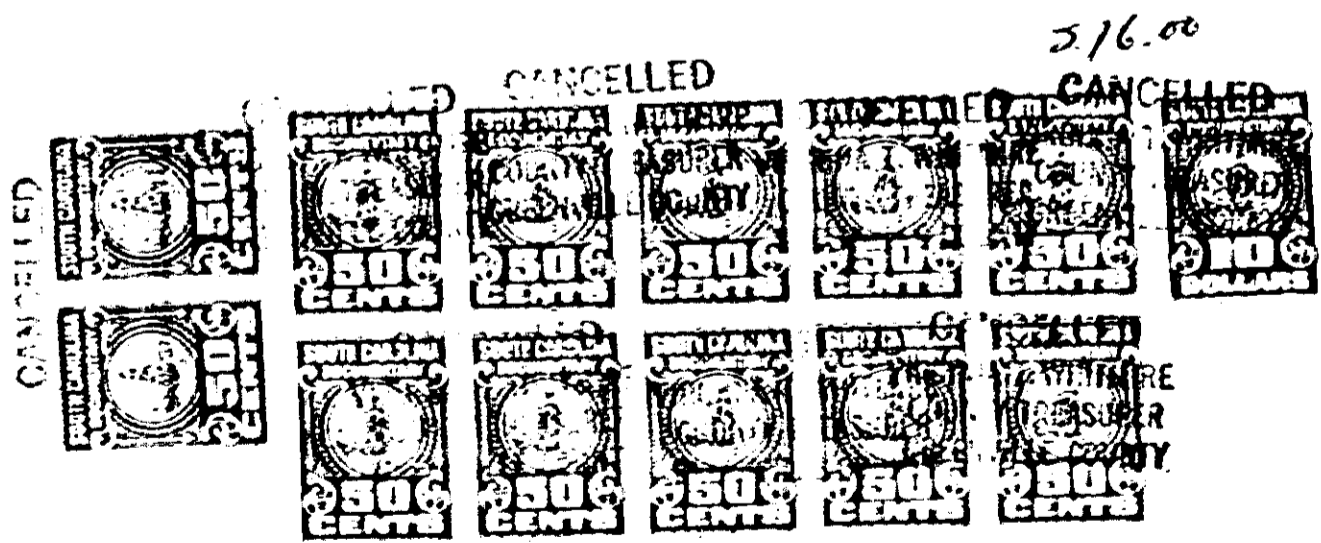

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 12 on plat of Kingsgate, Section 2, recorded in Plat Book 5 D at page 23 and having the following courses and distances:

BEGINNING at an iron pin on Swindon Circle, joint front corner of Lots 11 and 12, and running thence with joint line of said lots, S. 18-00 E. 150 feet to an iron pin, joint rear corner of said lots; thence with rear line of Lot 12, S. 73-02 W. 67.5 feet and S. 77-00 W. 139 feet to an iron pin, joint rear corner of Lots 12 and 13; thence with joint line of said lots, N28-02 E. 189.3 feet to an iron pin on Swindon Circle; thence with said Circle, S. 88-59 E. 35 feet and N. 47-25 E. 40.2 feet to the point of beginning.
