(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagoe) in the full and just sum of

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Three Hundred

WHEREAS, said note further provides that if at any time any poetion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagor, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaborate given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

That the Mictgages, in consideration of said delt and to secure the payment threed and any further sums which may be advanced by the Mictgages to the Mictgages's account, and also in consideration of the sum of Three Diffuss (\$3.00) to the Mictgages in hand well and truly paid by the Mictgages at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, largained, sold, and released, and by these presents does grant, largain, sell and release unto the Mictgages, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the southern side of Gibbs Shoals Road about one mile west from Pleasant Grove Baptist Church, and having, the following metes and bounds, to-wit:

Beginning on a nail and cap in the center of the said Gibbs Shoals Road, joint corner of a lot of 1.51 acres conveyed to S. R. Baugheme on November, 1972 and running thence with the common line of the Baugheme lot, S.33-18 E. 18 feet to an iron pin on the southern side of said road; thence continuing with the same course for a total distance of 336.7 feet to an iron pin on the Nichols line; thence with the said Nichols line, S.37-13 W. 201.5 feet to an iron pin on the said line; thence N.33-18 W. 351.6 feet to a nail and cap in the said Gibbs Shoals Road; thence with the center of said road, N.41-18 E. 196.8 feet to the point of beginning, containing 1.5 acres, more or less.
